To understand business is to understand the legal system which underlies all businesses and business transactions. During this course, students gain an understanding of the intersection between law, and business.




BUSINESS POLICY AND STRATEGY

Do I get credits for attending the program?

As a licensed institution, we offer credits, but it is ultimately the respective universities' decision to accept them.

How much time must I commit to the program each week?

You will have to commit to 12 hours of classes per week, plus an additional 3-4 hours for independent work. Company visits are also scheduled throughout the week, and last an average duration of 1.5-2 hours.

Will I be able to find housing accommodations in New York?
